3. Warranty Period: All the equipment, active and passive components supplied shall have OEM warranty for a period of 02 (years) years from the date of installation and commissioning.
4. Bidders should share all the relevant firmware/OS/Patches etc. as and when they are released by OEM during entire warranty period at no cost to CSIR-URDIP.

3. The bidder has to configure the RAID on the NVR system as per the requirement.
4. All cameras should be IP based and PoE.
5. The IP Based Video Surveillance system shall be a Hybrid System with distributed architecture having control station at the Server Room/designated location & Viewing facility at the Reception or any designated location.
6. After commissioning the Video surveillance system, the same shall be demonstrated for all its capabilities to the relevant user department to make them familiar with the system.
7. Once the Order is placed, it will be the vendors' responsibility to make the project functional. Any additional cost incurred for completing the project and for which the vendor has not bid at the time of submission of the final offer will be borne by the vendor.
